

ARTICLES OF INCORPORATION OF THE HERITAGE ASSOCIATION OF SAN MARCOS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of the age of twenty-one (21) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, adopt the following articles of incorporation for such corporation:

FIRST: The name of the corporation is The Heritage Association of San Marcos, Inc.

SECOND: The corporation is a non-profit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purposes for which the corporation is organized are:

- (a) To assist in the preservation of buildings, markers, historical sites, works of art, documents, papers, pictures, records and other writings of historical, traditional or cultural value.
- (b) To perpetuate those customs of the people, their traditions and folklore which beautify and enrich the community life of this city.
- (c) To discover and work towards the development of the areas of natural beauty and charm, as well as those locations of special natural historical interest within the city of San Marcos and its environs.
- (d) To disseminate knowledge, promote interest, encourage study and research and act in an advisory capacity to interested groups regarding the matters enumerated in this Article Fourth.
- (e) To cooperate with other persons, groups, organizations and agencies in effectuating the objectives set out in this Article Fourth.

FIFTH: The address of the initial registered office of the corporation is 50% East Hopkins Street, San Harcos, Texas, and the name of its initial registered agent at such address is Florine A. Oltman.

Amendment to the Articles of Incorporation

The Articles of Incorporation are hereby amended by adding:

Eighth

Upon dissolution of the corporation, the corporation shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, education, religious or scientific purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of Internal Revenue Code of 1954 as the corporation shall determine. Any of such assets not so disposed of shall be disposed of by a court of competent jurisdiction of county in which the principal office of the corporation is then located, exclusively for such purposed or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
